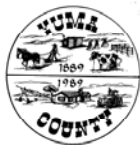
FULL SERVICE VSPC-ELECTION DAY

Mail Ballots must be returned to the Office of the Yuma County Clerk and Recorder, the Election Center or to one of the drop off locations, no later than 7:00 p.m., Tuesday, November 8, 2016 to be counted. Mail Ballots may be left at any VSPC location.
